

This book was very useful as an introductory text for executors dealing with the most common kind of wills and other matters of testate. It covers ordinary probate and the most common variations. These matters vary state-by-state of course, but if you don't have the good fortune (in a manner of speaking) to live in California or New York, you won't find many monographs written on probate etc in your own state. The author does a very good job of covering the general (Uniform Probate Code & the most common customs in the several States), and she makes well-selected references as well to salient and significant oddities in particular states, with tables etc that make this sort of thing easier to grasp. I recommend Hughes' and Klein's "Executor's Handbook" as well, and in fact it might be a bit easier to read that one first. But both are of great help and in difficult matters such as probate (for laypersons, anyway, who are the readers intended for the books) it's best to get the perspective offered by at least two sources; you'll unlikely want to pay two lawyers (and unless it's a very simple estate, with no possibility of being contested, you'll want a lawyer), so avail yourself of these books.

Sadly I had to read this on my way down to a spare of the moment time. I was an executor and I had to know more about what the job meant and this book did a good job on informing me. Though I wish you had put "Probate" closer to the start of this book as I was confused on the many times you spoke about it during the book. I ended up reading it in way later chapters. This covers many things I had to deal with and was(is) a great source of information. Something every one should read before any issues arise in ones life, as it will help you to prepare the job before some one passes away. The book gives you knowledge in a lot of areas that would help you prevent headaches after loss.

Such as ways to avoid "Probate". I do wish I had read this before hand. But it worked just as well after hand as well. Thank you for the book and your knowledge towards the subject.

Have only read excerpts from this book so far, but it has already helped me immensely. I felt lost and overwhelmed by the task of being Executor, but the book reduced it to human scale and laid a series of small, achievable tasks, Right off the bat, learned that the Estate was considered "small" and therefore qualified for a simplified probate process. That alone justified the purchase price!

Very good as all Nolo law books seem to be, but this one lacks some vital information: how to determine whether an estate even needs to be administered at all. After two court visits and a hefty fee to consult an attorney, I finally discovered the one I'd been named for required no executor actions at all.

Unfortunately, we all must face the situation where we are called upon to manage the estate of a deceased family member or friend. When this task is thrust upon us for the first time we are usually totally unprepared to find our way through the maze of procedural and legal issues. So, it was my good fortune to have taken the chance on this book. I needed help. I had no idea of what to do to

process the small estate of my family member. I tried this book since it was from NOLO press, known for making complex legal issues more understandable to the lay person. The author continued this tradition by writing a book that guides you through the executor's duties from the time of the death to the close of probate. It has tables and examples that cover major issues in all states. It defines all of the legal terms so that the average person can understand. It tells you how to handle small claims on your own and when to consult an attorney for more complex matters. Even covered tax issues. This book prepared me for the time when I did have to meet with an attorney. I was able to converse in a knowledgeable manner with the lawyer and this facilitated processing of the estate. I estimate that 99% of my questions were answered by reading this book. The other 1% required legal assistance. This book is highly recommended.
