

Love this book! It covers not just the legalities, but also the impact on family relationships of inheritances. I was part way through reading the book when my stepdaughter came to visit. She has shown little interest in her family's finances before (much to my son-in-law's chagrin) but she devoured this book. This book has practical, sounds advice tempered by real life experience. I highly recommend it for anyone who has more than one child, much less a blended family.

Easy read; some chapters only apply in certain situations, but those are still worth skimming through, to see the author's whole philosophy.

I recommend Beyond The Grave to anyone who has assets. It teaches you how to control what will happen to them after you are gone. This is such an important topic, whether you have children or not. With a tone of humor, this well-written book makes what could be a dry subject interesting and understandable. Real-life situations are examined and discussed to illustrate the pitfalls and benefits of various estate planning actions, and their probable outcomes. Diverse strategies are offered and examined as well. The author, a respected estate planning attorney, shares his wisdom and experience with readers in order to save them from mistakes that could (and probably would) cost their loved survivors large chunks of inheritance.

You never get tired of reading and studying these illustrations and practical cases. Sooner or later if you are in the risk management insurance business, sell life insurance or investments, you need to cross the line where the psychology and personal family thing matters, where you need to show you care and understand the real true sense of the word "empathy".

This book is well written, with real life examples to bring the concepts to life. The only problem I have with it is that some of the solutions Mr. Condon suggests are really not a viable option for people who are doing their estate plans. For example, he suggests buying life insurance to pay people who might otherwise be left out of your estate plan. If you are near or past retirement age (when most people start thinking seriously about estate planning), premiums on life insurance will not be cheap. If you have preexisting health issues, you may not be able to buy life insurance at any price. But overall this is a great place to start your planning.
