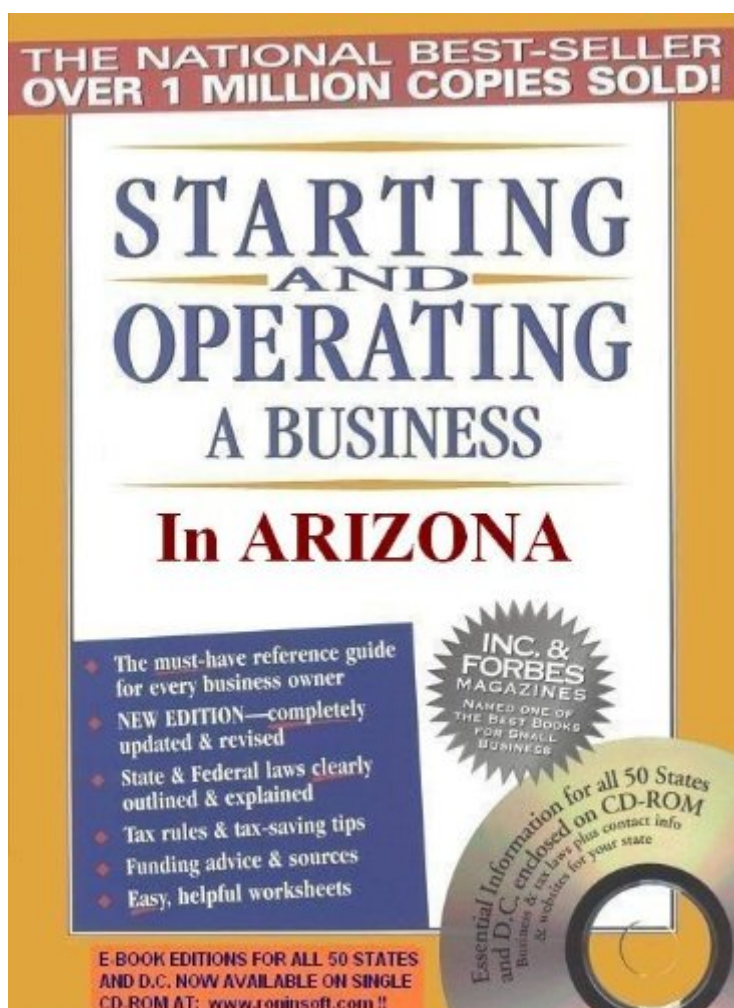

## Synopsis

Starting and Operating a Business in Arizona (May, 2017 Edition) is the most complete tax and legal guidebook in existence for Arizona small businesses. The roughly 500 pages (if printed) of each state edition in this e-book series offer far more than a dry description of the applicable business laws and taxes, however. The lively text is peppered throughout the book with key points to consider, including "Cautions," "Planning Points," "Important Points," and "Update Notes" that are highlighted to get your attention.

**FEDERAL LAWS AND TAXES**(This edition is fully updated for 2017 federal tax rates and brackets and 2017 retirement plan limitations, and the sweeping tax changes in the Consolidated Appropriations Act of 2016. Also updated for tax provisions of the 21st Century Cures Act that went into effect January 1, 2017.)Federal tax and legal coverage includes individual income, self-employment, estate, gift, and excise taxes, corporate income tax; payroll and withholding taxes; securities laws and regulations; environmental laws; minimum wage/overtime and child labor laws; ADA and other anti-discrimination and HealthCare Reform laws that apply to employers; immigration laws affecting hiring; OSHA job safety and health requirements; ERISA (employee benefits) compliance; the Family and Medical Leave Act rules; mail order sales and telemarketing regulations; Internet taxation and regulation; and much more.

**ARIZONA LAWS AND TAXES**(Updated for 2017 law changes, including reduced corporate tax rates, new incorporation/LLC filing procedures with the Corporations Commission, 2017 state minimum wage and increased personal property tax exemption, and new paid sick leave requirement for all employers that goes into effect July 1, 2017.)Arizona tax and legal coverage includes the Arizona state income tax, state corporate income tax, Arizona sales and use, property, and unemployment taxes, withholding of employee taxes, and other state and local business taxes; state fair employment laws, which may differ from federal; the Arizona minimum wage, overtime, and child labor laws; mandatory workers' compensation insurance and new hires reporting; wage payment requirements; when/if registration of fictitious business names (trade names) is required; other state labor laws; and much more.

**OTHER IMPORTANT INFORMATION AND ADVICE**In addition to extensive, up-to-date coverage of federal and Arizona business laws and taxes, you will also find this e-book to be a gold mine of other useful information and advice for running your business. It covers topics such as an entire chapter on site selection for your business; obtaining financing and choosing accounting methods; do's and don'ts when buying an existing business, acquiring a

franchise, or signing a lease; pros and cons of corporations, LLCs, and other business entities, as well as Arizona filing fees and taxes for each type of entity. Other chapters deal with subjects such as how to protect your assets from creditors; incorporation in a state other than Arizona; international ISO-9000 standards and certification of your business; use of Universal Product Codes, QR Codes, and RFID tags; how to classify workers as either employees or independent contractors; advice about joining a multilevel marketing program; exporting tips; cash flow management and fraud detection; and estate planning, to name a few covered topics.
