

#### Helpful; quick

I had our library purchase this book thinking it would be helpful to our students and instructors for preparing for the MCAT exam. I noticed immediately that the content was quite different than that of the AAMC practice exams, this book having relatively little biochemistry compared to the AAMC practice exams. I then found a question asking about how GMOs are made and how DNA is "removed" from one organism to place in another. There were several options including restriction enzymes and PCR. Having made GMOs myself I'm quite aware that BOTH PCR and restriction enzymes can be used to clone a gene. The answer section stated something along the lines of "PCR only copies DNA", which is technically accurate but that's also a perfectly acceptable way to "remove" a gene from an organism, by making a copy of it. Clearly whoever wrote these practice exams are lacking in some areas of expertise.

I found the questions easier compared to Kaplan and officially MCAT practice test, but still helpful with explanation of every question. Also would have loved to have an accurate scale related to the MCAT.
