

Additionally, the testimony of Karl Stroelin, the mayor of Stuttgart was put forth in this trial. Stroelin was involved in the deportation of 2,000 Jews from Stuttgart, the majority of whom were murdered in the death camps, and was thus found guilty in the trial, though he went through de-Nazification and was later released. Gustav Adolf Steengracht von Moyland, the Secretary of State for the Foreign Office during 1943-1945 was also called upon to testify along with Paul Otto Schmidt, who was a translator for Hitler during the surrender of France, the British declaration of War and the Munich Agreement.
