

Look, I know that dishing out almost ten bucks for each of these practice tests (PTs) sucks, but it is important. No prep book or test taking strategies can do the trick alone. The magic happens when you put what you've learned into practice with actual tests.Buy these, take them under perfectly simulated conditions (even find the testing room if you can), review them extensively to understand your mistakes, and kill it on test day. Between the 2 times I took the LSAT, I went through approximately 50 PTs. This prep had everything to do with my 97th and 99th percentile scores.

If you're studying for the LSAT, this is the only thing that you should be using. These are actual tests that have been administered. Why waste your time with other options that are only LSAT-like questions that people have written to mimic those of the LSAT?

The practice tests were by far the most helpful part of my LSAT prep. There was no substitute for

practicing on real tests, where you can time yourself, practice the endurance of a complete test, etc. If you are serious about getting a good score on the LSAT, you are going to need to take at least 20 of these bad boys. Definitely focus on the latest tests for the best idea of what to expect on your test day.

This is the second newest LSAT preptest, as of the time of this review (July 2013)The LSAT changes with time. You should definitely get the newest test, as new tests are the best indicator of what future tests will look like. Considering how important the LSAT is to your odds of admission, this book is well worth the price. You should also get the following books:LSATs 52-61LSAT 62LSAT 63LSAT 64LSAT 65LSAT 66LSAT 67LSAT 69The total cost of those books + this book is around \$70-\$80. You'll get 18 of the most recent, official LSAT preptests. There is no better investment you could make towards a better LSAT score.Note that only LSAT 69, LSAT 68 (this test), LSAT 67 and LSAT 66 have two pages for logic games diagrams. I recommend using only the second page for your diagrams. I've watched students draw diagrams far away from the questions, and it is surprisingly easy to lose your train of thought when you have to move your eyes across multiple pages.If you want more preptests, I recommend LSATs 29-38, which is only \$21 and has ten more fairly recent tests. I used these book's along with the lsat logic reading game bible series.. I didn't study very much and was able to score a 171..I attribute my success to these book's...The trick is drilling weak area's at the end of each week and ensuring you take a practice test at least once weekly. I would recommend about 15 practice tests to take in complete sittings and 15 for drilling weak areas.
